The Budget

- Maintains and enhances core educational and support programs, including continued implementation of the Common Core Learning Standards.
- Supports the introduction of three new Advanced Placement courses (Environmental Science, Art History, Spanish), the restoration of a volleyball team, new electives in social studies and technology, and support for special needs and ELL students.
- Supports additional positions needed due to growth in enrollment and state mandates.
- Continues the full-day kindergarten program for 2015-2016.
- Maintains the science research program at the high school.
- Maintains secondary summer school, Regents review classes, sports, late buses, clubs and field trips.
- Authorization of Capital Reserve Fund Projects: With voter approval, at no additional cost to taxpayers, the district will expend \$1.5 million from the existing capital reserve fund established in March, 2009 for districtwide repairs and renovations including safety and security upgrades, bathroom renovations, ceiling and window replacements.

Financial Management

- The tax levy decrease of .09% is the third tax levy decrease within the past eight years.
- The average Freeport homeowner will not incur any additional cost if the budget is approved.
- The average tax levy increase for the last seven years is 2.13%.
- Freeport spends approximately \$5,300 less per pupil and collects approximately \$8,900 less in tax levy per pupil than the average district in Nassau County.
- Freeport's Standard and Poor's bond rating is AA, a rating earned by only a few of the 300 districts rated.
- In the past several years, the district implemented \$25.6 million in capital improvement projects at no cost to taxpayers through Energy Performance Contracting and our EXCEL bond.
- Refinanced outstanding bond payments, thus saving taxpayers \$2.6 million in interest costs.
